OPERATING INSTRUCTIONS

Disney's Princess Castle

**DO NOT OPERATE THE KINDAS' JUMP IN WINDY OR UNFAVORABLE WEATHER CONDITIONS.
KINDAS' JUMPS CAN TURN OVER BY HIGH WINDS SEVERELY INJURING OCCUPANTS.**

Make sure that the **KINDAS' JUMP** is fully inflated before letting riders inside. Never allow riders on a partially inflated unit. All riders must remove their shoes and empty their pockets of any hard objects that can injure themselves or others while jumping. Eyeglasses and jewelry should also be removed. This includes watches, bracelets, necklaces, etc...

Riders should all be of the same age group and should be limit to the maximum numbers of riders shown below. Never allow more riders in the unit than is shown. A competent adult must supervise the unit at all times.

In the event of severe weather, remove all riders from the unit and unplug immediately. Make sure the unit remains securely anchored. Do not reinflate unit until adverse weather conditions cease. When conditions permit, inflate unit and allow it to dry before using again. Never allow playing on a wet unit.

If the **KINDAS'** inflatable becomes unplugged or losses power during the operation, the attendant should hold open the door and allow the riders to exit. There is no cause for alarm, riders should be told to remain calm and follow the attendant's instructions.

- G. **DO NOT EXCEED THE RECOMMENDED CAPACITY** _____
- H. **NO TOYS, EYEGLASSES, WET KIDS OR JEWELRY** _____
- I. **NO SILLY STRING IN OR AROUND THE INFLATABLE** _____
- J. **NO BALLONS, STRINGS, SIGNS, ETC ATTACHED TO UNIT** _____
- K. **NO PAINTED FACES, MAKE-UP THAT WILL STICK TO UNIT** _____
- L. **WHO WILL SUPERVISE UNIT? NAME(s)** _____
