## **OPERATING INSTRUCTIONS**

### **Lava River**

**DO NOT OPERATE THE KINDAS' JUMP IN WINDY OR UNFAVORABLE WEATHER CONDITIONS.  
KINDAS' JUMPS CAN TURN OVER BY HIGH WINDS SEVERELY INJURING OCCUPANTS.**

Make sure that the **KINDAS' JUMP** is fully inflated before letting riders inside. Never allow riders on a partially inflated unit. All riders must remove their shoes and empty their pockets of any hard objects that can injure themselves or others while jumping. Eyeglasses and jewelry should also be removed. This includes watches, bracelets, necklaces, etc...

**Riders should all be of the same age group** and should be limit to the maximum numbers of riders shown below. Never allow more riders in the unit than is shown. A competent adult must supervise the unit at all times.

In the event of severe weather, remove all riders from the unit and unplug immediately. Make sure the unit remains securely anchored. Do not reinflate unit until adverse weather conditions cease. When conditions permit, inflate unit before using again.

If the **KINDAS'** inflatable becomes unplugged or losses power during the operation, the attendant should allow the riders to exit. There is no cause for alarm, riders should be told to remain calm and follow the attendant's instructions.

**GENERAL RULES FOR SAFE OPERATION**

- A. NO FLIPS, NO ROUGH PLAY. FEET FIRST AND ON YOUR BACK WHEN SLIDING DOWN \_\_\_\_\_
- B. NO SHOES OR SHARPS OBJECTS IN OR AROUND THE INFLATABLE \_\_\_\_\_
- C. NO FOOD, DRINKS OR GUM IN OR AROUND THE INFLATALBE \_\_\_\_\_
- D. MUST BE SUPERVISED AT ALL TIMES \_\_\_\_\_
- E. CHILDREN MUST CLIMB UP ONE AT A TIME. DO NOT MIX AGE \_\_\_\_\_
- F. MUST SLIDE DOWN ONE AT A TIME IN EACH LANE. IT COULD BE VERY DANGEROUS SLIDING MORE THAN ONE AT A TIME IN EACH LANE. \_\_\_\_\_
- G. DO NOT EXCEED THE RECOMMENDED CAPACITY 1 AT A TIME \_\_\_\_\_
- H. NO TOYS, EYEGLASSES, OR JEWELRY \_\_\_\_\_
- I. NO SILLY STRING IN OR AROUND THE INFLATABLE \_\_\_\_\_
- J. NO PAINTED FACES, OR ANY MAKE-UP THAT WILL STICK TO UNIT \_\_\_\_\_
- K. NO BALLONS, STRINGS, SIGNS, ETC ATTACHED TO UNIT \_\_\_\_\_
- L. POOL AND UNIT MUST BE FREE OF WATER (DRY) AND CLEAN AFTER USE \_\_\_\_\_
- M. FOLLOW UNIT'S INSTRUCTIONS ATTACHED TO IT \_\_\_\_\_
- N. DO NOT PLAY AROUND UNIT. KEEP AT LEAST 10 FEET AWAY. VERY DANGEROUS \_\_\_\_\_
- O. WHO WILL SUPERVISE UNIT? NAME(s) \_\_\_\_\_
